

## Terms and Conditions

Welcome to the International School of Bucharest ("ISB", "School", or "us" in the following) website. By using our website (the "Website"), you agree to comply with and be bound by these Terms and Conditions (the "Terms"). Please read them carefully before using the Website. If you do not agree to these Terms, please do not use the Website.

ISB is headquartered in Șoseaua Gării Cățelu nr. 1R, Bucharest, District 3, Bucharest, Romania and is operated by Lumina Instituții De Învățământ Foundation, headquartered in Șoseaua Colentina nr. 64B, District 2, Bucharest, Romania, registered with the Register of the Associations and Foundations of Sector 2 Courthouse under no. 02/16.03.2011, Fiscal Code RO16224225. ISB is an educational establishment providing pre-school, primary, lower secondary and upper secondary education corresponding to the educational system of England and Wales, based on Certificate no. 1112 of 18.05.2016 issued by the Ministry of National Education, accredited by the Council of International Schools, member of COBIS.

### 1. Definitions

In these Terms, the following definitions apply:

- "Content" means any and all text, images, videos, graphics, data, and other material available on or through the Website.
- "User" or "you" means any person who accesses or uses the Website, whether as a visitor or a registered member.

### 2. Acceptance of Terms

By using the Website, you represent and warrant that you have read, understood, and agree to be bound by these Terms. If you are not eligible, or do not agree to the Terms, you must not access or use the Website.

### 3. Modification of Terms
